Mayor Mueller questioned which newspaper the Council would like to select as the City's official newspaper for 2020.

Council Member Gunn recommended the *Pioneer Press* be the secondary newspaper for the City given their overall coverage of the City.

Council Member Hull suggested the *Shoreview Press* serve as the City's primary newspaper for 2020.

MOTION/SECOND: Gunn/Hull. To Select the *Shoreview Press* as the City's Primary Newspaper for 2020 with the Secondary Newspaper being the *Pioneer Press*.

Council Member Meehlhause asked if selecting a primary and secondary newspaper was a State requirement. City Attorney Riggs reported this was the case.

MOTION/SECOND: Gunn/Meehlhause. To Waive the Reading and Adopt Resolution 9199, Selection of the Acting Mayor, Treasurer and Official Newspaper and Depositories for 2020.

City Administrator Zikmund requested the Council consider various appointments to the City's boards, commissions and committees. He noted the Council previously discussed this matter on December 30th and tabled action to this meeting in order to allow staff to speak with several of the candidates.

Mayor Mueller reported the Federal Government was seeking assistance with the 2020 Census if residents had additional time in their schedule to assist with this task. She noted a minor typo on Resolution 9200 and requested staff to make the change.
